Ordinance Levying and Assessing Property Tax for Peru Public Library of the Counties of La Salle and Bureau, State of Illinois for the Fiscal Year Beginning 1 July 2018 and Ending 30 June 2019

WHEREAS, the President and Board of Trustees of the Peru Public Library, in the Counties of LaSalle and Bureau and State of Illinois, on 13 September 2018 passed the Annual Budget and Appropriation Ordinance (Ordinance No. 18/19-004) for said Library District for the fiscal year commencing on July 1, 2018 and ending June 30, 2019; and

WHEREAS, said Annual Budget and Appropriation Ordinance was published as provided by law after its passage;

NOW, be it ordained by the President and Board of Trustees of Peru Public Library, in the counties of La Salle and Bureau, State of Illinois, as follows:

<u>Section I</u>: That the total sum of Six Hundred Ninety-Five Thousand Three Hundred Sixteen Dollars (\$695,316), composed as follows:

The sum of Four Hundred Nineteen Thousand Dollars (\$419,000.00), being the amount deemed required for the necessary corporate purposes of Peru Public Library, LaSalle and Bureau Counties, Illinois; the sum of Twenty-Two Thousand One Hundred Eighty-Eight Dollars (\$22,188), being required for the payment of employer contributions of Peru Public Library to the FICA Fund; the sum of Twenty-Eight Thousand Five Hundred (\$28,500), being required for the payment of employer contributions of Peru Public Library to the Illinois Municipal Retirement Fund; the sum of Five Thousand Dollars (\$5,000), being required for the payment of the professional opinion of an accountant and other auditing expenses from an Audit Fund; the sum of Forty-Five Thousand Six Hundred Twenty-Eight Dollars (\$45,628) for the purpose of payments of premiums due for the purchase of liability insurance, workers' compensation and unemployment insurance, property damage (fire) insurance and legal fees for defending or otherwise protecting itself against liability from a Liability Fund; the sum of Fifty Thousand Dollars (\$50,000), being required for the maintenance, repairs and alterations of library buildings and equipment from a Maintenance Fund; and the sum of One Hundred Twenty-Five Thousand Dollars (\$125,000), being required for a Working Cash Fund, be and the same is hereby levied and assessed upon and against all taxable property within this Library District according to the full fair value as established and ascertained for State and County purposes for the fiscal year beginning July 1, 2018 and ending June 30, 2019 and the Board of Trustees of the Peru Public Library, on 13 September 2018 duly passed and adopted the Annual Budget and Appropriation Ordinance for the fiscal year beginning July 1, 2018 and ending June 30, 2019 and said Ordinance having been duly published in a newspaper of general circulation within this Public Library District, this Board finds that the specific purposes and the specific amounts provided for in said Annual Budget and Appropriation Ordinance, a copy of which is attached hereto and by this reference made a part hereof, are required to be levied for the necessary purposes of the Peru Public Library.

## **Tax Levy Ordinance**

<u>Section 2</u>: The Secretary of the Board of Trustees of the Peru Public Library is hereby directed to file a duly certified copy of this Ordinance with the County Clerks of LaSalle and Bureau Counties, Illinois, in accordance with the laws of the State of Illinois, on or before the last Tuesday of December 2018; and said County Clerks are hereby authorized and directed to extend the said tax so levied by this Ordinance, according to law, against all taxable property within the Peru Public Library. The Secretary of Peru Public Library shall also file on or before the last Tuesday of December 2018, duly certified copies of the Annual Budget and Appropriation Ordinance and this Ordinance with the Peru Public Library where they shall be available for public inspection as provided by law.

<u>Section 3</u>: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.
