

# Annual Budget & Appropriation Ordinance

25-26 002

Annual Budget and Appropriation Ordinance for the Fiscal Year Beginning 1 July 2025 and Ending 30 June 2026

WHEREAS, The Board of Trustees of the Peru Public Library, of the Counties of LaSalle and Bureau, State of Illinois, have prepared a tentative form of the Combined Annual Budget and Appropriation and which has been conveniently available for public inspection for at least thirty days prior to final action; and

WHEREAS, a public hearing was held as to such Annual Budget and Appropriation Ordinance on 11 September 2025, notice given at least thirty days prior thereto as required by law, and all other legal requirements have been duly complied with.

BE IT ORDAINED by the Board of Trustees of the Peru Public Library District of the Counties of LaSalle and Bureau, Illinois, as follows:

SECTION 1: That the following sums, or so much may be authorized by law, are budgeted, set aside and appropriated for the specified Library Purposes for the fiscal year beginning July 1, 2025 and ending June 30, 2026; and the objects and purposes for which said appropriations are made, and the amounts thereby appropriated are as follows:

SECTION 5. That a certified copy of this ordinance be published at least once after passage in a newspaper published or circulated in the District.

SECTION 6. This Ordinance is effective immediately upon passage and approval.
